**THURSDAY, NOVEMBER 10, 2011**

**OPENING EVENT:** The 123<sup>rd</sup> Convention of the Episcopal Diocese of Oregon began with Evening Prayer led by Megan Rosevear of St. Paul's, Salem followed by *Welcoming the Reign of God in the Church: Sorry, What was that Jesus?* The Rev. John Dally of Seabury-Western & Garrett-Evangelical Theological Seminaries, Evanston, Illinois, presented this first portion of his convention presentation. The evening closed with Compline led by Sean Wall, Postulant from Christ Church, Lake Oswego

**FRIDAY, NOVEMBER 11, 2011**

**MORNING PRAYERS:** Led by Coleen Howard, Postulant to the diaconate from St. Aidan's, Gresham

**CALL TO ORDER:** The Rt. Rev. Michael J. Hanley, Bishop of Oregon, called the convention to order at 9:05a.m. Bishop Hanley offered a prayer for convention and then asked all veterans and those currently serving in the armed forces to stand and be acknowledged for their service.

**ADDITIONAL RESOLUTIONS OF POLICY:** The Bishop called for any late Resolutions of Policy. The Rev. Bingham Powell, Chair of the Committee on Resolutions of Policy presented the following:

**Late Resolution I** – Submitted by Recovery Commission. Asks the convention to establish a consistent guideline for offering the Sacrament of wine to those who do not desire to drink from the cup and that the diocesan standard be the training of Eucharistic Ministers to say the words of institution while holding the cup of wine close to themselves in response to a communicant's crossed arms over chest. It was moved and passed to refer to the Committee on Resolutions of Policy.

**Late Resolution II** – Submitted by Recovery Commission. Asks the convention to reaffirm the 8.2.7 Policy on the Use of Alcohol from the January 1991 Diocesan Convention resolution. It was moved and passed to refer to the Committee on Resolutions of Policy.

**Late Resolution III** – Submitted by the Rev. Stephen Denny, Deacon, St. John the Evangelist, Milwaukie. Asks the convention to petition the 77<sup>th</sup> General Convention of the Episcopal Church to adopt the resolution entitled "Pursuing a Just Peace in the Palestinian/Israeli Conflict" and that prior to the 77<sup>th</sup> General Convention of the Episcopal Church the Diocese of Oregon implement its own study of the Holy Land. It was moved and passed to refer to the Committee on Resolutions of Policy.

**REPORT OF THE ACADEMY FOR FORMATION & MISSION:** Bishop Hanley yielded the chair to Secretary Neysa Ellgren as he presented report. The Bishop reported that it has been a good year at the Academy. There are currently 17 students, with excellent teaching going on. He thanked Lee Garrett who was dean last year and the board for their work. Because of financial challenges due to structure, Lee recommended eliminating his own position and the Bishop commended him for this. The Academy has been restructured to focus on teaching using the funds for this purpose. The position of dean has been eliminated and the board has stepped down. The Rev. Kurt Neilson and the Rev. Dn. Maureen share the work of running the Academy. Currently teaching people in the ordination track and those interested in discerning for ordination. Working on increasing enrollment and expanding the Academy as an education opportunity for anyone who wants to learn what it means to be in ministry. Need to add elements of teaching for others, including small intensives and online, and partnering with CDSP to do some work on this. Believe the Academy will be self supporting. Current funding sources are tuition and the Bishop's Fund.

**REPORT OF THE PERSONNEL COMMITTEE:** The Bishop thanked outgoing chair Florette Lewis for her leadership and for bringing a lay employee voice to the committee. Florette reported that the Personnel committee was formed in 1983. In 2007, the diocesan convention put the Personnel Committee under the purview of Diocesan Council. The committee, with help from Mary Macy and Ken Ross, publishes the SHU chart: the salary, housing, utility schedule for clergy. They work on the policies and procedures manual and insurance resolution. Florette commended Marlyn Flanders and Mary Macy for their work.

**REPORT OF THE ENVIRONMENTAL COMMISSION:** Alice Speers, Convener, presented the annual Energy Conservation Grants and Environmental award. Living out the call to become more sustainable St. John the Divine, Springfield and St. Stephen, Newport each received \$500 for light retrofit. St. Philip the Deacon in Portland received \$500 to help cover the cost of new 92% efficient furnaces. St. Edward, Silverton received a \$50 grant towards an energy audit to help make their parish more energy efficient. The Environmental Award was presented to Good Samaritan, Corvallis for installing the first solar array in the diocese.

**REBUILD OUR CHURCH IN HAITI APPEAL:** Leslie Sackett reported that over \$33,000 has been raised so far and was thankful for the overwhelming generosity.

**BISHOP'S CROSS AWARD:** Bishop Michael Hanley announced he will reveal the recipient of the Bishop's Cross Award in the coming week on the OECN Online.

The first recipient of this award is one highly deserving of recognition. This person was a clear voice of continuity during the initial days of the interim period between Bishop Itty's leave-taking and my election as bishop. This individual has been described as the glue that held things together with personal integrity, a thoughtful and joyful attitude and as one who was able to take the ministry of the diocese seriously without taking herself seriously.

With a sense of humor and a willingness to be available to everyone Mary Cramer helped the diocese navigate the challenging early days of the transition period. Mary has been called faithful, positive, thoughtful, a good listener and one who is totally present to whoever she is with. She has also been called firm and no-nonsense, a person willing to look at options and sacrifice for the good of the diocese she served.

### **"PROTESTANT EPISCOPAL BISHOP OF OREGON (CORPORATION SOLE)"**

This corporation is a Corporation Sole, represented by the Bishop and his successors in office, in perpetuity. A convenient legal depository of funds and property held for the benefit of the Church. The funds are administered by the Bishop and invested in the Diocese of Oregon Pooled Investment Fund.

### **"THE DIOCESE OF OREGON"**

The Church in this Diocese is incorporated under the name of The Diocese of Oregon, 11800 SW Military Lane, Portland, Oregon 97219. The corporation holds in trust all property given for objects connected with the Church in this Diocese other than property held by parochial or other corporations. The Bishop and the Officers and Board of Trustees, elected by the Diocesan Convention, administer the funds.

### **"LEGACY GOOD SAMARITAN HOSPITAL AND MEDICAL CENTER"**

A part of the Legacy Health System, this nonprofit corporation controls, manages and operates Legacy Good Samaritan Hospital and Medical Center, 1015 NW 22<sup>nd</sup> Avenue, Portland, Oregon 97210. The Bishop and one Director, elected by Diocesan Convention, serve on the Legacy Health System Board of Directors.

### **"GOOD SAMARITAN HOSPITAL CORVALLIS"**

This nonprofit corporation controls, manages and operates the Good Samaritan Hospital Corvallis, 3600 NW Samaritan Drive, Corvallis, Oregon 97339. The Bishop is the Chairman of the Board of Directors and appoints two additional Board members.

### **"SAMARITAN VILLAGE"**

This nonprofit corporation controls, manages and operates Samaritan Village, 285 NW 35<sup>th</sup> Street, Corvallis, Oregon 97330, the retirement facility sponsored by The Diocese of Oregon. This facility has been in operation since September 1, 1962 and continues to operate at full capacity, with a short waiting list. The Bishop is President of the Board of Trustees.

### **"OREGON EPISCOPAL SCHOOL"**

This nonprofit corporation controls, manages and operates Oregon Episcopal School, a school for boys and girls, formerly known as St. Helen's Hall and Bishop Dagwell Hall, at 6300 SW Nicol Road, Portland, Oregon 97223. The Bishop serves as Chairman of the Board and the Diocesan Convention elects nine Trustees, annually electing three Trustees to serve three-year terms on a rotation basis.

### **"CENTER FOR COMMUNITY COUNSELING"**

This nonprofit corporation controls, manages and operates the Center for Community Counseling, 1465 Coburg Road, Eugene, Oregon 97401, a counseling agency. The Bishop appoints one member of the Board of Directors.

## **Resolution Number 1: Clergy and Lay Employee Medical and Dental Health Coverage**

Resolved that the Diocese of Oregon meeting in November 2011 in its 123<sup>rd</sup> Convention, maintain health insurance coverage that includes both medical and dental benefits for clergy and lay employees in accordance with Oregon Diocese Resolution 1 of the 122<sup>nd</sup> Convention. Health insurance coverage would apply equally to clergy and lay employees who work a minimum of 20 hours per week (1000 hours per year). And be it further

Resolved that congregations and missions are encouraged to assume 100% of cost related to clergy and lay employee health insurance premiums as has been tradition, however, they may exercise a premium sharing arrangement with employees who shall assume a maximum of 20%.

Resolved that diocesan leaders and leaders of congregations and missions, lay and ordained, commit themselves to a course of prayer, study and action to insure that all people, rich or poor, employed or unemployed, have parity of affordable access to the quality of health care that we who are employed in the Episcopal Church in the Diocese of Oregon are privileged to enjoy.

## **Late Resolution II: Reaffirmation of Policy on the Use of Alcohol in the Diocese**

Resolved that we reaffirm and change the 8.2.7 Policy on the Use of Alcohol, to reflect current state law, which reads as follows:

The January 1991 Diocesan Convention adopted the following points of policy concerning the use of alcoholic beverages at church sponsored events, on church property or at other locations.

1. Whenever alcohol is served in any form, non-alcoholic beverages must always be offered and served with the same attractiveness and accessibility as those containing alcohol. They should be clearly labeled as such. This also applies to any food where alcohol has not been volatilized. Common courtesy excludes pressing upon people any food or drink.
2. Although these guidelines recognize the long-standing tradition of the use of alcoholic beverages, they also recognize that excessive drinking is always unacceptable Christian behavior. Care always must be taken to insure that responsible persons are in control of serving alcoholic beverages. ~~Any parish or mission that serves alcoholic beverages to the public is urged to attend Server's School through OLCC or a Community College.~~
3. It is the duty of the clergy in charge of the congregation, or in his or her absence, the Wardens and Vestry, to assume responsibility for the dissemination and enforcement of these guidelines.
4. Any group or organization sponsoring an activity or event at which alcoholic beverages are served must assume full legal responsibility for those persons who might become intoxicated, including the provision of transportation for anyone whose driving might be impaired.
5. ~~All occasions at which alcoholic beverages are to be offered publicly must be licensed.~~ All applicable federal, State and local laws and ordinances, including those governing the serving of alcoholic beverages to minors, must be observed.

from the Diocese of Oregon:  
Pursuing a Just Peace in the Palestinian/Israeli Conflict**

Resolved, the House of \_\_\_\_\_ concurring, that the 77th General Convention, mindful of the impasse in reaching a just resolution to the Israeli/Palestinian conflict, calls on the Executive Council (using appropriate staff) to develop and implement a strategy of advocacy and education in the Church during the next triennium to further a just resolution of the conflict utilizing existing policies and resources, including but not limited to the following:

- A robust use of the Episcopal Public Policy Network in promoting Church policies in our nation's capital;
- Participating in corporate social responsibility by more vigorous and public corporate engagement with companies in the Church's investment portfolio that do business in illegal Israeli settlements or contribute to the infrastructure of the Occupation;
- Identifying a project of economic engagement through a loan of at least \$200,000 from the Church's economic justice loan fund that strengthens the economic infrastructure of the Territories;
- Assist individual Episcopalians by providing information on products made and distributed from illegal Israeli settlements so that they can make informed consumer choices;
- An examination of actions the U.S. might take to support international law and human rights;

and be it further

Resolved that Council include in its planning a study in the next triennium in every Diocese of "KAIROS PALESTINE 2009" released in December 2009 by Palestinian Christian leaders to address the plight of Palestinian Christians living under military occupation in the West Bank and Gaza as well as those Christians living within the state of Israel who do not enjoy the full rights and privileges of Jewish-Israeli citizens; and be it further

Resolved that the Council further consider using as a resource for this study plan an Episcopal version of Steadfast Hope (adapted from the Presbyterian original) as developed by the Palestine Israel Network of the Episcopal Peace Fellowship; and be it further

Resolved that the Standing Commission on Anglican and International Peace with Justice Concerns give high priority to peace with justice in the Holy Land and report to the 78th General Convention of The Episcopal Church with recommendations on how best to support our Anglican brothers and sisters in the Holy Land; and be it further

Resolved that all bishops, clergy and lay people of the Episcopal Church in the United States be encouraged to travel to the region as pilgrims and witnesses, and to provide various forms of support for the Church in the Holy Land, including the Episcopal Diocese of Jerusalem, its parishes, and its Bishop, The Rt. Rev. Suheil Dawani, including through the sterling work of the Friends of the Episcopal Diocese of Jerusalem and the Good Friday Offering; and be it further

Resolved that Convention request the Joint Standing Committee on Program, Budget and Finance to consider a budget allocation of \$5,000 for the implementation of this resolution.

## **Late Resolution IV: Calling for Reorganization of The Episcopal Church**

This work should include, but not be limited to, a review of staffing organization at the national and provincial levels, program focus and delivery, and revenue sharing. And be it further

Resolved, that the SCSC report its findings and recommendations to the 78th General Convention (2015) of The Episcopal Church for further action.

## **Constitutional and Canonical Changes**

### **Canon 7.4 of Parochial Reports**

WHEREAS it has been determined that the present requirement of Canon 7.4 regarding the date of filing of annual Parochial Reports by February 1<sup>st</sup> is difficult for parishes to meet;

NOW BE IT RESOLVED that Canon 7.4, Section 1 be amended to read as follows:

Sec. 1. Every Parish and Mission shall prepare a report annually for the year ending December 31st, upon the form adopted by the General Convention, and shall send it no later than ~~February~~ **March** 1st to the Bishop, or if there is no Bishop, to the Secretary of the Diocese.

**Action of Convention: PASSED BY TWO-THIRDS IN EACH ORDER.**

## REPORT OF THE BOARD OF TRUSTEES

I am pleased to be able to address you about the work of your Board of Trustees over this last year. The report is brief, but a number of important actions have been taken by the Board which I know you will wish to hear about.

Each year it is our task to make grants and loans to various parishes and organizations in the diocese. This year considerations were made for St. John's in Bandon where the Board approved the use of St. John's own financial resources for building repairs and the building of a handicapped access ramp.

Several grants were made from 2010 program budget surplus monies: a grant to St. Mary's in Gardiner for nearly \$5,000 for the installation of a new roof with the congregation also paying for a percentage of the cost of the roof through their own funds. An additional action by the Board was the approval of a request by the Diocesan Council to transfer an amount of surplus funds to the 2012 budget—this amount has been a part of the convocation explanations for the 2012 budget. A grant was also made from surplus funds to St. Hilda's in Monmouth for an \$ 11,000 grant to support the cost of the installation of a handicapped ramp.

Other actions by the Board from funds held in trust by the Board include: \$5,000 for camper scholarships. Again this year we had a record number of kids who attended camp and we are grateful to the leadership of Beth Dieker and those of you in the diocese who volunteered as camp counselors and helpers.

The Board made a significant but unusual grant to the diocese, itself, to purchase and install an Arena database system. We have been operating with a system for a very long time and this installation will increase our ability to make a significant upgrade to a newer system. The cost for this new system will be in the range of \$23,000.

A third year grant was made to St. David of Wales in Portland for \$65,000 to continue the renewal and growth needs of that parish. In terms of St. David's, a five year grant request was submitted three years ago and the Board annually reviews the progress of St. David's prior to making any additional yearly grant. I wish to, again, commend the Rev. Sara Fischer and the vestry and people of St. David's for their growth in both parish membership and also for the many community programs that are operated inside and outside of the parish.

As all of us know the diocese has had to assist in the redevelopment of the staffing at St. Matthew's in northeast Portland. The Board has made a grant of \$25,000 to the parish as they continue to grow a larger and newer parish congregation.

This last year St. Thomas in Eugene discovered some major problems with roof, wall and window leaks. The Board granted a loan to St. Thomas' of \$150,000 for these repairs. The repairs done by St. Thomas are nearing completion and will provide a water tight building for parish worship.

Over this last year the diocese has encountered a couple of legal case issues and has had to grant money to the work of the Chancellor's office to support and defend the legal position of the diocese. This amount granted was \$15,000 toward this effort.

The 2009 audit of the diocese is in final review and I want to especially thank Mary Macy for the difficult work of preparing for this audit. Three years of audits have been accomplished in the period of two years and Mary has worked diligently with her Finance Department colleagues to make this possible.

In total, the Board of Trustees in assuming their fiduciary responsibility made decisions of over \$400,000 in diocesan funds in loans and grants.

I wish to thank two retiring members of the board—the Rev. David Sweeney and Mr. James Baxendale. I know that I speak for the Board when I say that they have provided invaluable service and the Board appreciates the gifts and abilities that David and James have given.

I also wish to thank our Bishop, Michael Hanley for his astute Episcopal leadership as the president of the Board of Trustees; to Paul Dakopolos for his many contributions as a member of the Board and Chancellor of the diocese; to Mike Stone, our Treasurer for the hours that he has put in the completion of the sale of Triangle Lake as well as signing a few hundred checks each month; Mary Macy for the incredible effort she puts in as the Finance Officer of the diocese, along with the other staff of that department; and to Marie Bagwell who is the glue that keeps us all together. It's a joy to work with and be associated with these leaders of the Diocese of Oregon. It has been a pleasure for me to serve on the Board of Trustees. Thank you. – The Very Rev. Anthony Thurston

## **REPORT OF THE TREASURER**

Presented by The Very Rev. Anthony Thurston on behalf of Mike Stone, Treasurer

**PAROCHIAL REPORTING:** A renewed focus has been implemented on parochial reporting and the review of submitted reports due to the revision of Canon 5.2.3 stressing consistency and accuracy of reporting from the congregations.

**DPA VISITATIONS:** Representatives from the Board of Trustees, Diocesan Council and the Standing Committee continue to visit congregations who have asked for a meeting to discuss their financial condition as well as considering cancellation of delinquent DPA payments. The process is a lengthy and time consuming process which provides a unique opportunity to meet, review and forward a solution based proposal to the DPA committee for consideration. The process continues to provide an avenue of meeting with the decision makers in the congregations as well a time to discuss their concerns, listen to the outreach activities within their communities and how best to encourage their success.

**BUDGET COMMENTARY:** Budget information is presented monthly by Mary Macy to the Board of Trustees as well to the Finance Committee. The budget as of 2010 was on track based on the predictions made two years ago. The 2011 budget is on schedule with regard to both income and expenses and it is meeting all forecasted expectations.

**CHANGES IN SOFTWARE:** Mary Macy will be leading the project of changes in our software program so that parishes will be able to take advantage of the small business health care credit, if eligible, and for parishes to be able to report separately, including payroll. Reports by the Finance Department will be made easier rather than the current systems that are in place. Also, it is planned to rebuild and reorganize the accounting systems at the diocesan level.

**TRIANGLE LAKE PROPERTY:** After a thorough, deliberate, thoughtful, lengthy financial analysis, the Triangle Lake Task Force made the recommendation in 2007 to pursue placing the Triangle Lake Convention property in a moth ball condition because lack of camping participants as well as selling the property to recover expenses. A successful camping program was created in an agreement with the Methodist Church which has created a successful and exciting camping experience for our children. After four years of effort the property was sold for 1.3 million with the Bishop signing the closing documents on August 31,2011. Provisions of the Task Force recommendations will be place in motion.

## BISHOP'S ADDRESS

### *Still at Hand*

Bailey, my black and white Shetland sheepdog, and I were walking in Foothills Park in Lake Oswego when we encountered a group of standing stones. A memorial to William Stafford, who was a poet laureate and longtime resident of the area. On one of the stones is carved these words: "Oregon is insanely green; it is the thin light left over from Eden."

I stop, Bailey sniffs the ground. For a moment, I find myself held in a vision of the reign of God on earth. The reign of God appears at times such as these: standing there, the light of Eden filtering through the trees, the smell of earth, the flight of a bird seen out of the corner on my eye. Silence. The reign of God is all around us here in Oregon, seen clearly by many in earth and sky, water and lush green. But also found in the people who traveled the length of the continent to settle here: seen in their words and actions, in their passions and tenacity.

We Episcopalians who live here in Oregon are privileged to be able to proclaim the reign of God while we live Gospel lives. In order to live our lives in faithful obedience to this call, we need to be clear about just what this reign of God is, and how we might find our way to living now in that reign.

Jack Nelson Pallmeyer in his book, *Jesus Against Christianity*, makes the following statement about the kingdom or reign of God: "The kingdom of God is present on earth whenever life accurately reflects the will and sovereignty of God. It is the way life and society would be if a compassionate God were in charge or imitated instead of Roman governors, client kings, and the temple establishment." Jesus said, "The reign of God is at hand!" He said it more than once; in fact, he said it a lot and gave a lot of examples of what it looked like: a pearl of great price, a lost coin, a banquet, the treatment of a man beaten by the side of the road, what it means to be blessed, how our debts are paid, how we go after a lost sheep, and how a father treats a prodigal son. This litany goes on and on. And the good news is that the reign of God is still at hand.

In the Diocese of Oregon, it is our joy to discover the Kingdom—to live in the Kingdom and to make that Kingdom a reality for others. This past year I've had the privilege of traveling all around this diocese and to several countries around the world and I'm here to tell you—the Kingdom of God is still at hand! I've seen the Kingdom late at night in Ashland when I overheard a young woman telling a friend about this cool labyrinth she discovered on the grounds of Trinity Church. I've seen it in the ladies of that oddly named town of Drain who keep the church going so that their afterschool program has a place to meet and continue to grace the lives of the children of the town. It's here in Salem and around the diocese when a church gives over property for a community garden where Spanish speaking immigrants gain access to produce grown by their own labor. The kingdom is over on the coast in a community offering a new Spanish language Mass and placing a beautiful statue of Our Lady of Guadalupe behind the altar. It's in Portland in the offering of communion in the park to homeless men and women, in the work being done to offer alternatives to women whose lives are lived on the streets, and in the willingness of clergy and laity alike to take a stand against those who would isolate us into factions, for we are indeed all in this life together.

The actions we take as individual Christians, as members of congregations, and as the larger body of the diocese, help us to live in the reign of God. The plans we create together serve as an information network we use to insure that our priorities are consistent across the diocese, allowing us to join together with an

effective voice for God in community. Put simply: if our plans are unclear, our actions will have less power for good.

This past year, I invited the diocese to consider the creation of a new mission plan. During this process I've been acutely aware of the observations of Dr. Margret Wheatley on organizations and change. Dr. Wheatley reminds us that "organizations are never changed by assembling a new set of plans, by implementing directives, or by organizational restructurings." They change themselves instead along three primary, dynamic domains: identity, information and relationships. In other words, organizations adapt and thrive based on how well they understand why they exist, how well they communicate internally and externally, and how well they build relationships. Organizational change occurs when we use our shared sense of identity to organize our contributions, when we interpret our situation in new ways - letting go of our certainty and current views—and when, through our relationships, we share information that transforms us.

The mission process we have worked through the past year was designed to engage our past identity, to look at information in new ways, and to build relationships that invite transformation. The mission plan we share with you today is based in the diocesan identity already found in the mission documents created in this diocese during the last several years. In the document you will find the echo of a 1997 council statement, a 2008 vision plan, and the 2009-10 bishop search process material. I reformatted this information and added my voice to the conversation in March of this year during a trip to the school for new bishops. Then, based on Wheatley's observation that change is forged through strong relationships, I tested it in relational conversations with the Standing Committee, the Board of Trustees, the Diocesan Council, diocesan staff, Bishop Bob Ladehoff, Deacon Janis Hansen, the convocations, the Anti-Racism Commission, the Christian Formation Committee, and a professional consultant from outside the Episcopal Church. Toward the end of the process, I had the best and most challenging critic I know help to perfect the language so that the language moves toward action and measurable outcomes. That critic was my professor wife! The document was still being revised even this past Monday.

It comes to you today with the support of—and formal approval voted by—members of the Standing Committee, Diocesan Council, and the Board of Trustees. Thank you to everyone who offered thoughtful feedback. The plan invites congregations and the diocese to work in four Strategic directions: Congregational Life, Diocesan Mission, Leadership Development, and Gospel Justice. The plan then further breaks these areas down to some very specific actions. You will get a copy of this mission plan at the end of my address and you can see the four main areas and all of the detail underneath these areas. The mission plan is intended to be a working document and to develop over the coming years. I invite you, as leaders in your congregations, to explore the plan and discover for yourselves those specific areas most important for your own communities. Today I'd like to highlight, for each of the four strategic directions, one step I believe we need to focus on in the coming year.

First, among the several categories of work under the strategic direction "Congregational Life," the plan calls for the review and development of programs concerning liturgy and preaching development. At the parish level, I encourage clergy and lay worship committees to study current practices of liturgy and preaching and to be intentional about how liturgy is planned and how the preaching of the Gospel is accomplished week in and week out. On the diocesan level, I will provide programs that support and enhance liturgical celebrations and Gospel preaching. This will be a top priority for me in the coming year.

And why am I concerned with this? Because I believe that God's reign can be discovered on earth in good liturgy and Gospel preaching. The Midnight Mass service that delighted a newcomer into returning the next week and the sermon we thought of for weeks after its delivery which led us to make changes in our

life - these are examples of how reaching and liturgy further the reign of God. What we know about being a faithful follower of Jesus Christ comes to us most strongly in community liturgy on Sunday mornings. The second strategic direction is “Mission Development.” As a priority, I believe we need to implement effective and creative management structures, to clarify roles, streamline operations and use resources wisely. One example of work underway in this area is the job descriptions we have developed for the diocesan staff and—coming soon—the creation of model job descriptions for congregations. Why do I think it important to do this work? Because we are better at being the people of God when such clarity is present in our relationships. When our finances are clear and open, people are willing to give financially to support our vision of the reign of God. When we are clear about roles and we include specific term limits, people are treated with respect and dignity and can give us a clear “yes” or “no” to an invitation to serve in a particular way. Frankly, such organization has not been a priority in the diocese for years, and it is essential that we update what we are doing in this area now.

The third strategic direction is called “Missional Leadership.” I believe it is imperative that we continue the work started by COM-B to help people understand their calling to lay ministry alongside the calling to an ordained ministry. The Episcopal Church has a history of being a clergy-dominated faith community where the call to a lay ministry is seen as a lesser call than the call to ordained ministry. Yet ordained ministry is but a small part of the totality of the call God has invited us to as a people gathered in the name of Jesus to live in God’s reign now.

A renewed emphasis on the ministry of all the baptized has enormous potential for invigorating the Church in the 21st Century. Many parishes are making do with fewer clergy hours and many of these congregations are learning that they can continue to be vibrant centers of mission and ministry because each member knows that his or her ministry is essential to the whole. Some congregations are discovering a renewed vitality because they have to rely heavily on lay ministry. Imagine a congregation where it is difficult to know who the priest is because everyone is being “priest” to one another!

The final strategic direction concerns Gospel Justice. I will be asking us to begin a new diocesan companion relationship and to create and sustain other various global partnerships. We need to discover what is already happening in all the congregations of the diocese in terms of global and local Gospel Justice Work. Once we know what we are already engaged in, congregations can better partner together, leveraging our capacity to act in a deep and powerful way.

This year I traveled in India, Ecuador and Mexico; the challenges each have in building a society where people are treated with respect and dignity are apparent. Here at home, it is also obvious that not all people are treated equally, not all people have the same access to basic goods and services, and not everyone is understood as a child of God worthy of love and compassion. Voices are calling out for effective policies in the United States, and the Church needs to bring God’s vision of love and compassion to the conversation. A moral principle is at stake here: if the Church does not proclaim the Gospel of God’s love for all people, who will proclaim it?

I believe that by taking this mission plan to heart and by being attentive to its vision to proclaim the reign of God while living Gospel lives, individual congregations and the diocese as a whole will enter more often into God’s reign. We will have excellent clergy and lay leaders working together. We will form disciples of Jesus Christ who have the skills and commitment necessary to live as Christ in the world. We will be a people who are proud and passionate about being Episcopalians, and people willing to share our sense of mission in the world. We will be leaders standing up and sharing God’s vision of a world renewed, a world guided by a compassionate God.

The reign of God is found in our daily human interactions, in how we organize our work, attend to the needs of others, advocate for justice and care for the beautiful earth on which we depend.

To bring that image fully alive for us now, I've turned to a piece written in another day and time for another green and foggy country. I could have chosen a YouTube of this work performed by Emerson, Lake & Palmer, Charlotte Church, or sung at the Royal Wedding. The YouTube video version I've chosen has a particularly Oregon-esque weirdness. As you watch and listen, substitute the words "Oregon" every time William Blake wrote "England".

And now let's stand and sing ourselves:

And did those feet in ancient time  
Walk upon England's (Oregon's) mountains green:  
And was the holy Lamb of God,  
On England's (Oregon's) pleasant pastures seen?

And did the Countenance Divine,  
Shine forth upon our clouded hills?  
And was Jerusalem builded here  
Among these dark Satanic Mills?

Bring me my Bow of burning gold;  
Bring me my Arrows of desire;  
Bring me my Spear: O clouds unfold!  
Bring me my Chariot of fire!

I will not cease from Mental Fight,  
Nor shall my Sword sleep in my hand:  
Till we have built Jerusalem,  
In England's (Oregon's) green & pleasant Land.

I pray the work we do this day, the time we spend in convention, might allow us to glimpse the reign of God and proclaim that God's reign is still at hand.

We are providing this letter in connection with your audit of the statement of financial position of The Diocese of Oregon as of December 31, 2009 and the related statements of activities, and cash flows for the year then ended for the purpose of expressing an opinion as to whether the financial statements present fairly, in all material respects, the financial position, changes in net assets, and cash flows of The Diocese of Oregon in conformity with U.S. generally accepted accounting principles. We confirm that we are responsible for the fair presentation in the financial statements of financial position, changes in net assets, and cash flows in conformity with generally accepted accounting principles. We are also responsible for adopting sound accounting policies, establishing and maintaining internal control, and preventing and detecting fraud.

We confirm, to the best of our knowledge and belief, as of November 3, 2011, the following representations made to you during your audit.

1. The financial statements referred to above are fairly presented in conformity with U.S. generally accepted accounting principles and include all assets and liabilities under the Diocese's control.
2. We have made available to you all –
  - a. Financial records and related data
  - b. Minutes of meetings of the Board of Trustees, or summaries of actions of recent meetings for which minutes have not yet been prepared.
3. There have been no communications from regulatory agencies concerning noncompliance with, or deficiencies in, financial reporting practices.
4. There are no material transactions that have not been properly recorded in the accounting records underlying the financial statements.
5. We acknowledge our responsibility for the design and implementation of programs and controls to prevent and detect fraud.
6. We have no knowledge of any fraud or suspected fraud affecting the Diocese involving –
  - a. Management
  - b. Employees who have significant roles in internal control, or
  - c. Others where the fraud could have a material effect on the financial statements.
7. We have no knowledge of any allegations of fraud or suspected fraud affecting the Diocese received in communications from employees, former employees, grantors, regulators, or others.

8. The Diocese has no plans or intentions that may materially affect the carrying value or classification of assets, liabilities, or net asset balances.
9. The following, if any, have been properly recorded or disclosed in the financial statements:
  - a. Related party transactions including revenues, expenses, loans, transfers, leasing arrangements, and guarantees, and amounts receivable from or payable to related parties.
  - b. Guarantees, whether written or oral, under which the Diocese is contingently liable.
  - c. Significant estimates and material concentrations known to management that are required to be disclosed in accordance with FASB Accounting Standards Codification 275, Risks and Uncertainties.
10. We are responsible for compliance with the laws, regulations, and provisions of contracts and grant agreements applicable to us; and we have identified and disclosed to you all laws, regulations, and provisions of contracts and grant agreements that we believe have a direct and material effect on the determination of financial statement amounts or other financial data significant to the audit objectives.
11. The Diocese of Oregon is an exempt organization under Section 501 (c)(3) of the Internal Revenue Code. Any activities of which we are aware that would jeopardize the Diocese's tax-exempt status, and all activities subject to tax on unrelated business income or excise or other tax, have been disclosed to you. The Diocese is exempt from filing IRS Form 990.
12. Receivables recorded in the financial statements represent valid claims against debtors for sales or other charges arising on or before the statement of financial position date and have been reduced to their estimated net realizable value.
13. There are no:
  - a. Violations or possible violations of laws and regulations and provisions of contracts and grant agreements whose effects should be considered for
  - b. disclosure in the financial statements, as a basis for recording a loss contingency, or for reporting on noncompliance.
  - c. We are not aware of any pending or threatened litigation, claims, or assessments or unasserted claims or assessments that are required to be accrued or disclosed in the financial statements in accordance with FASB Accounting Standards Codification 450, *Contingencies*, and we have not consulted a lawyer concerning litigation, claims, or assessments.
  - d. Other liabilities or gain or loss contingencies that are required to be accrued or disclosed by FASB Accounting Standards Codification 450, *Contingencies*.
  - e. Designations of net assets disclosed to you that were not properly authorized and approved, or reclassifications of net assets that have not been properly reflected in the financial statements.
14. The Diocese has satisfactory title to all owned assets, and there are no liens or encumbrances on such assets nor has any asset been pledged as collateral.

15. We have complied with all restrictions on resources (including donor restrictions) and all aspects of contractual and grant agreements that would have a material effect on the financial statements in the event of noncompliance. This includes complying with donor requirements to maintain a specific asset composition necessary to satisfy their restrictions.

16. In regards to the assistance in drafting the financial statements and disclosure notes services performed by you, we have:

- a. Made all management decisions and performed all management functions.
- b. Designated an individual with suitable skill, knowledge, or experience to oversee the services.
- c. Evaluated the adequacy and results of the services performed.
- d. Accepted responsibility for the results of the services.

17. The methods and significant assumptions used to estimate fair values, including not readily marketable securities are as follows:

*Money Market:* Valued at the net asset value (“NAV”) of shares held by the Diocese at year end.

*Common Stock:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Diocese at year end.

*Investment in Partnership:* Valued on the equity method accounting; whereby, the initial investment is increased or decreased based on the investment’s annual income (loss) activity.

18. We believe the effects of the uncorrected financial statement misstatements summarized in the attached schedule are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. In addition, you have proposed adjusting journal entries that have been posted to the organization’s account. We are in agreement with those adjustments. Except as discussed in Note 16 to the financial statements, no events have occurred subsequent to the statement of financial position date and through the date of this letter that would require adjustment to, or disclosure in, the financial statements.
